

BFGOODRICH ADVANTAGE / G-FORCE™ SPORT COMP-2™ 'FOUR FOR THREE'
OCTOBER 2017 PROMOTION

TERMS AND CONDITIONS

1. Information on how to enter form part of these Terms and Conditions. Participation in this Promotion is deemed acceptance of these Terms and Conditions.
2. The Promotion commences at 7.30am AEST on 1 October 2017 and ends at close of business in Participating Dealers (as defined below) on 31 October 2017.
3. In order to qualify for the Promotion, individuals must purchase, in a single transaction, a set of three (3) BFGoodrich Advantage T/A Drive or a set of three (3) BFGoodrich Advantage T/A SUV or a set of three (3) BFGoodrich G-FORCE™ SPORT COMP-2™ tyres from any Participating Dealer (as defined below) in Australia between 7.30 am AEST on 1 October 2017 and close of business on 31 October 2017 ("**Qualifying Transaction**"). "**Participating Dealer**" means any dealers in Australia that display advertising material for this Promotion during the promotional period or are listed online at www.bfgoodrich.com.au.
4. An Individual who completes a Qualifying Transaction at a Participating Dealer ("**Eligible Individual**") will be awarded one (1) free BFGoodrich Advantage T/A Drive or one (1) free BFGoodrich Advantage T/A SUV or one (1) free BFGoodrich G-FORCE™ Sport Comp-2™ tyre at the time of the Qualifying Transaction.
5. The free 4th BFGoodrich Advantage / G-FORCE™ SPORT COMP-2™ tyre must be similar and of equal or lesser value to the tyres purchased under the Qualifying Transaction. Eligible Individuals will receive free BFGoodrich Advantage / G-FORCE™ SPORT COMP-2™ tyre at time of purchase.
6. BFGoodrich Advantage / G-FORCE™ SPORT COMP-2™ free tyre offer does not include any additional fitment tyre service fees. Eligible Individuals will have to pay for fitment tyre services.
